Following the two business meetings and the program, there will be a brief meeting of the newly formed *Stone Street Cemetery Preservation Association, Inc. (SSCPA)*.

### <u>Minutes of Stone Family Reunion and Stone Street Memorial Association Meeting of 7/30/16</u> (submitted by John Buck, Secretary)

The combined meetings of the Stone Family Reunion and Stone Memorial Association were held at the Rush Volunteer Fire Company Auxiliary Hall at Lawton, PA on 7/30/16. This event was the 114th Stone Reunion. Chaplain Jessie Birchard Carr provided a welcome to the attendees and gave the invocation. Continuing the tradition, the meal was excellent and enjoyed by all.

President Betty Handrick Baldwin welcomed everyone and recognized the two honorary members in attendance, Courtland Bradshaw Birchard of Birchardville, PA and Curtis C. Stone of Brooklyn Township, PA. Several new attendees were introduced including Debbie, Ron, and Justin Smith; Andrew Stone and his daughters Emily and Alexis; and Joyce and Frank Chrostowski of Greenwood, Missouri. The Chrostowskis were temporarily given the award for travelling the farthest, but that was later reversed to recognize Lyn Munn's trip from Arizona.

Betty reviewed accomplishments during the year which included initiating a website <u>www.stonefamilyreunion.com</u>. The website has portions that are still under construction, but several photos and articles are available in the archives. The site is continuing to be revised and added to. Betty also discussed the successful formation of the Stone Street Cemetery Preservation Association, Inc., organized under Pennsylvania non-profit statutes.

Betty thanked everyone for the wonderful food, thanked Jessie and Bob Carr for continuing to store and transport the Reunion photos and the large family tree that always draws attention, and thanked the officers for their efforts. She went on to review some of the attendees of the 1928 Reunion that were obtained from the old sign-in book. Almost everyone present had ancestors who attended that Reunion 88 years ago.

Secretary/Historian John Buck next provided his report. On motion of Christine Buck, 2nd by Courtland Birchard, the reading of the minutes of the 2015 Reunion were dispensed with and the minutes were unanimously accepted. John reported on recent communications with Arthur Bradshaw, Ron Hilton, and Karon Mott. Karon reported that her father, Fred Leon Mott, Jr. had passed away October 9, 2015. Fred was predeceased by Jean (Greene) Mott in 2009 and they had three children. John indicated that Jean Mott was a seventh generation Stone descendant, and her parents were Frank Herbert Ball and Ella K. Small. On motion of Christine Buck, seconded by Courtland Birchard, the report was accepted unanimously.

Co-Treasurer Bob Carr handed out copies of the separate Treasurers' reports for the Stone Reunion and the Stone Street Memorial Association. Bob pointed out that the most significant expenses for the SSMA continue to be for grounds-keeping maintenance at the Stone Street Cemetery. He also noted, continuing recent trends, that we are not receiving any significant interest income from our various accounts and no longer have the option of participating in Treasury Direct bond purchases. That situation may improve with the formation of the SSCPA. On motion of Chris Buck, seconded by Lyn Munn, the reports were accepted unanimously. (*Financial reports are presented in the next section*)

Under other business, President Betty Baldwin noted that on 5/22/16 a preliminary organizational meeting of the newly formed "Stone Street Cemetery Preservation Association, Inc." (SSCPA) was held at the home of Jessie and Bob Carr. The officers are the same officers as for the Stone Family Reunion. With spouses, the SSCPA membership comprised seven individuals at the meeting and By-Laws were proposed

and adopted. There was no cost to either the Stone Family Reunion or the Stone Street Memorial Association for the formation of the SSCPA. Betty noted that any interested party is welcome to join the SSCPA and that membership applications were available.

A motion was made by Betty Baldwin and seconded by John Buck that an additional \$50 be provided to the Rush Volunteer Fire Company for the use of their excellent facility, and the motion passed unanimously. Betty thanked John Buck for his work on getting the website, <u>www.stonefamilyreunion.com</u> functioning. Jim Baldwin was thanked for his excellent photography in recording the 2015 and 2016 Reunions.

Eileen Birchard, as chair of the Nominating Committee, suggested that the current slate of officers continue for another term. Absent further nominations, a motion was made by Chris Buck, seconded by Dave Shadduck, and passed unanimously to accept the current slate of officers. Motion to adjourn was made by Betty Baldwin, seconded by Bob Carr, and the meeting adjourned at approximately 2 pm.

The first part of the program was a discussion by Lyn Munn about making a silver concho belt for her daughter. The project was done in the winter months in Arizona, and Courtland Birchard assisted. The links of the belt were silver castings made with molds made by the "lost wax" process. Emily Stone assisted by modeling the belt, and all agreed that the project was a success.

The second part of the program was a presentation by John Buck on the history of burials at the Stone Street Cemetery over a period of about 1817 to the present. (Some aspects of this presentation are available on the website.) John concluded that although Stone Street started as a community graveyard comprising several unrelated neighboring families, every one of the 108 known burials is now related to the founding Stone family, either by direct line or by marriage.
