President's Message

It is with deep regret that we announce the cancellation of the concellation of the 2021 Stone Family Reunion.

As this mailing is being prepared there has been considerable progress in Covid infection rates and in vaccinations for the Covid virus. Various restrictions are in the process of being eased, but a substantial part of the population remains unvaccinated. Because of the continuing risk, the officers believe it to be in the best interests of all to cancel the Reunion. The officers will hold their meetings and conduct the normal business of the Reunion.



Because there was no Stone Reunion or Stone Street Cemetery Preservation Association (SSCPA) meeting in 2020, there are no minutes to send in this mailing. The officers did meet electronically on 5/26/2020 and 5/29/2021 and reviewed the financials. All officers and directors agreed to continue in their current positions until a Reunion and membership meeting can be held.

Bob and Jessie Carr have submitted interim financial statements for the Stone Reunion and also the SSCPA. The statements are available on the website at http://stonefamilyreunion.com or can be mailed on request. These financials indicate that the two entities together spent approximately \$980 for cemetery maintenance, mailing expense, and website hosting during the previous year. The expenses were offset by donations of approximately \$1,030. Income from investments was approximately \$80. Bob and Jessie also reported that the required IRS filing of form 990-N was done in February 2021. As has been discussed previously, the officers intend to consolidate the financials from the Stone Reunion into the SSCPA during the coming year. Most of the expenses are currently incurred by the SSCPA, and unifying to one set of financial statements would simplify accounting and reporting. If any member has questions or comments on the consolidation of finances, please contact one of the officers.

We want to extend special recognition to some of our most active Honoraries in the Reunion. Ruth (Handrick) (Blair) Furman will be 102 years of age in July, Curtis Stone will be 99 in November, and Courtland Bradshaw Birchard will be 91 in a few days. Congratulations and thanks to our Honoraries!
